We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2021-22 educational progress for Kment Elementary School. For the 2022-23 school year, schools were identified based on previous year's performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2018-19. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2017-18. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2016-17. Some schools are not identified with any of these labels. In these cases, no label is given.

- \* Note TSI and ATS definitions were changed for the 2018-19 school year per federal requirements. The new definitions are:
- TSI The school has at least one subgroup performing in the bottom 25% within each applicable accountability index component.
- ATS The school has met the criteria for TSI identification and has at least one subgroup performing at the same level as a CSI school.

Kment Elementary School has not been given one of these labels for the 2018-19 school year. Therefore, we continue not to have an identification as outlined above.

For the 2021-22 school year, Kment Elementary School served approximately 250 students in preschool (GSRP) through Fifth Grade. Kment also houses two special education resource classrooms for students identified through the child study process. These students range in grade from kindergarten through 2nd. Students were assigned to Kment Elementary School according to their home residence. Families also had the opportunity to apply for a transfer to and from other schools within Roseville Community Schools. In addition, Roseville Community Schools participated in the school of choice program throughout Macomb County.

Kment Elementary has a continuous School Improvement Plan based on state and federal mandates and requirements. Staff members continue to implement strategies identified for the goal areas of reading, writing, science, math, and culture/climate. All staff members were involved in the planning and implementation of this plan. Data from local and state assessments were used to support changes and implement strategies. Specific building challenges are detailed in the school improvement plan.

Kment Elementary school enjoys a strong parent group and volunteers. We frequently have parents volunteering in classrooms and for event planning. Kment's PTO works diligently to promote attendance, school spirit, and overall community. The school has a 93% participation in Parent-Teacher Conferences during the October meeting All of our teachers are in regular contact with parents through various media daily.

During the 2018-19 school year we adopted/implemented a new Math program. Everyday Math continued being implemented in the 2019-20 school year with

teachers receiving regular training and coaching from McGraw-Hill trainers. The 2019-2020 also saw an adoption and implementation of new 3rd-5th grade reading series. The Wonders reading program provides a more in depth look at comprehension and word craft aimed at helping students be better readers for information and understanding. The Wonders ELA program has been adopted for grades k-2 beginning with the 2022-23 school year. At the outset of the 2019-20 school year, the district began training on the Schoology Platform and made plans for a 1-to-1 device roll out. Currently, all RCS students have a district provided device. I am proud of our staff for their continued efforts in reaching all students and ensuring a high-quality education for all. I am also proud of the Kment students as they work assiduously to perform remarkably across the curriculum.
